Glossary

EOTAS - (Education other than at school)

EHE Elective Home Education - this is where a parent or guardian decides that the child will be educated at home rather than in a school.

CME Children Missing Education - children of compulsory school age who are not registered pupils at a school and are not receiving suitable education otherwise than at a school.

PRU Pupil Referral Unit - a type of school that caters for children who aren't able to attend a mainstream school. Pupils are often referred there if they need greater care and support than their school can provide

SEND Special Educational Need and Disabilities - a child has special educational needs and disabilities if they have a learning difficulty and/or a disability that means that they need special health and education support

SEND Support - This is additional educational help for children with SEND, it will be individual for the child but could include working with a teaching assistant in a small group.

EHCP An Education, Health and Care Plan (EHCP) - identifies educational, health and social needs and set out the additional support to meet those needs. They can be requested of the local authority for children and young people aged 0-25. If the local authority agrees to an EHCP, they should be completed within 20 weeks, although there are three exceptions to the 20 week deadline. An EHCP is also subject to an annual review.

All CYP with EHC Plans without an education setting for whom we are actively seeking a specialist setting Of the full cohort of CYP with an EHCP without an education setting recorded, this represents those for whom consultation for a specialist setting is being undertaken




EHC Plans by NCY School Phase






% CYP have an amended EHCP by the statutory deadline 15th February (Statutory school age)





% CYP have an amended EHCP by the statutory deadline 31st March (post-16)


